New administration console	You can use the new CylanceHYBRID administration console to see the version history, set some configuration parameters, perform troubleshooting steps, view licenses, files, and registry settings, and deploy updates. The CylanceHYBRID Status page is still available for managing the application, including maintenance mode and cache settings.	January 2022
CylanceHYBRID 2.0 functions with a variety of virtualization software	CylanceHYBRID 2.0 now works with a variety of virtualization software on Ubuntu 20.04, including VMware ESXi, Microsoft Hyper-V Server, Citrix Xen, and Nutanix AHV. Note: With the release of CylanceHYBRID 2.0, users are responsible for maintaining their virtual environment updates as necessary.	January 2022

CylanceHYBRID fixed issues

If you requested the status of a background threat detection from the CylancePROTECTagent, a "Not Found" error was returned. (AG-1161)
If you made changes to a device policy, the updated policy might not have been delivered to CylancePROTECT devices. (EPCL-4477)
When requesting the status of a background threat detection, an error message was returned. (AG-1161)
Disk usage steadily increased on a running CylanceHYBRID instance. (AG-1076)
Time zones might have been incorrect in policy timestamps. (AG-945)

The Test Connection button for testing the Active Directory connection was enabled even if the username or password fields were empty. (AG-931)

The CylanceHYBRID global file list validation was not the same as the list in the management console. (AG-865)

CylanceHYBRID known issues

You can edit and save network settings in the console without first enabling maintenance mode. (AG-1147)

When you try to update a macOS agent using the management console, the update fails with a 404 error. (AG-1192)
